

OUR PRIVACY POLICY

Cambridge City Chauffeurs Limited Privacy Policy

SECTION 1 - What do we do with your information?

When you enquire about any of our services, as part of the buying and selling process, we collect the personal information you give us such as your name, address and email address. When you browse our website, we also automatically receive your computer's internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.

SECTION 2 – Consent

How do you get my consent?

When you provide us with personal information to request a quotation or complete a transaction, verify your credit card, place an order, arrange for a delivery or return a purchase, we imply that you consent to our collecting it and using it for that specific reason only. It is unlikely your personal information is asked for a secondary reason, like marketing, we will either ask you directly for your expressed consent, or provide you with an opportunity to say no.

How do I withdraw my consent?

If after you opt-in, you change your mind, you may change your mind and withdraw your consent for us to contact you, for the continued collection, use or disclosure of your information, at any time, by contacting us personally.

SECTION 3 – Disclosure

We may disclose your personal information if we are required by law.

SECTION 4 – Payment Via Card

If you choose a direct payment gateway to complete your purchase, it is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS). Your purchase transaction data is stored only as long as is necessary to complete your purchase transaction. After that is complete, your purchase transaction information is deleted. All direct payment gateways adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover—DSS requirements help ensure the secure handling of credit card information by our store and its service providers.

SECTION 5 - Third Party Services

In general, the third-party providers used by us will only collect, use and disclose your information to the extent necessary to allow them to perform the services they provide to us.

However, certain third-party service providers, such as payment gateways and other payment transaction processors, have their own privacy policies in respect to the information we are required to provide to them for your purchase-related transactions.

For these providers, we recommend that you read their privacy policies so you can understand the manner in which your personal information will be handled by these vendors. In particular, remember that certain providers may be located in or have facilities that are located in a different global area, than other than yours or ours.

If you elect to proceed with a transaction that involves the services of a third-party service provider, then your information may become subject to the laws of the jurisdiction(s) in which that service provider or its facilities are located. As an example, if you are located in Canada and your transaction is processed by a payment gateway located in the United States, then your personal information used in completing that transaction may be subject to disclosure under United States legislation, including the Patriot Act.

Once you leave our website or are redirected to a third-party website or application, you

are no longer governed by this Privacy Policy or our website's Terms of Service.

SECTION 6 - Security and Personal Information

To protect your personal information, we take reasonable precautions and follow industry best practices to make sure it is not inappropriately lost, misused, accessed, disclosed, altered or destroyed. If you provide us with your credit card information, the process is encrypted using secure socket layer technology (SSL) and stored with a AES-256 encryption.

Although no method of transmission over the Internet or electronic storage is 100% secure, **we follow all PCI-DSS** requirements and implement additional generally accepted industry standards which is constantly monitored periodically though out the year.

SECTION 7 - Age Of Consent (global)

By using this site, you represent that you are at least the age of majority in your state or province of residence, or that you are the age of majority in your state or province of residence and you have given us your consent to allow any of your minor dependents to use this site.

SECTION 8 - Changes to the Privacy Policy
